Who to Call and When

To Our Valued Foster Care Parent or Child Care Provider: Please be aware that there can be severe consequences, both short and long-term, when a child is arrested and charged with a crime. On the bottom of this page you will find examples of how an arrest may impact a child. The following individuals are available to assist you in providing information in your time of crisis or to provide guidance to you and your child before a crisis occurs.

Counselors and Mental Health:

Role in the Dependency/Delinquency System: The FCSOC provides children and families access to mental health services in Pinellas County when there are no other financial resources available to meet the family's needs. Access to a variety of school-based, office-based and in-home mental health services are available to eligible families. There is no cost to the family for the mental health services that the family is linked to. Families are also assisted in utilizing their mental health insurance benefits.

When to Call: 8:30 a.m. to 5 p.m., Monday-Friday

(b) <u>Contact Information:</u> Post Detention Community Services (PDCS), Gayle McNeill: 727-456-0600, Ext. 2245

Role in the Dependency/Delinquency System: The PDCS program provides in home assessment, case management and linkage to families whose child has experienced a first time detainment at the Juvenile Detention Center or the JAC. The program provides up to 3 months of services to stabilize the child and help ensure that the child has other focus activities beside delinquent behavior.

When to Call: 8 a.m. to 5 p.m., Monday-Friday

(c) <u>Contact Information:</u> Emergency Response Team (ERT), on-call: 727-504-0340 <u>Role in the Dependency/Delinquency System:</u> The ERT provides in home crisis intervention, assessment and linkage for 6-8 weeks to families whose child(ren) are at

risk of removal due to abuse/neglect. The eligibility for the program is that the family must live in Pinellas County, a child in the family must be at risk of removal, and one of the following issues must be present – Mental health, Substance Abuse, Domestic Violence or Child Behavior. Referral source is the Sheriff's office CPID and ECA.

When to Call: Anytime, 24 hours a day, 7 days a week

Role in the Dependency/Delinquency System: Youth and family evaluations with recommendations for services and assistance obtaining services when ordered by the court. Assistance with alternatives to incarceration at JDC.

When to Call: May be of assistance if family/youth has been evaluated and is having difficulty obtaining appropriate services.

Removal, Case Management and Dependency Proceedings:

Role in the Dependency/Delinquency System: Child Protection Investigators work to protect children and work with families who are subjects of allegations of abuse, neglect and/or abandonment received by the Florida Abuse Hotline. Some examples of job duties include removing children from unsafe environments, supervising them, and arranging transportation to an approved shelter facility or home. In addition, investigators also arrange and/or refer families to social services entities and testifies in judicial proceedings.

When to Call: The Pinellas County Sheriff's Office, Child Protection Investigations Division is a contracted provider by the Department of Children and Families. Any concerns of Abuse, Neglect or Abandonment must be made to the Florida Abuse Hotline (1-800-96-ABUSE), not by directly calling the Sheriff's Office. If a report is accepted by the hotline concerning a child under the age of 18 who resides in Pinellas County, the Pinellas County Sheriff's Office-CPID will be forwarded the report and will conduct an investigation of the allegations. The assigned investigator in consultation with supervisory staff and dependency attorneys will determine if legal sufficiency exists to warrant a child's removal from their caregivers based on findings of the allegations called to the hotline. Once a child is removed and the dependency process is initiated, the child's case is staffed with Eckerd Community Alternatives and the family is assigned a case manager.

Role in the Dependency/Delinquency System: The GAL Program is appointed by the court primarily in dependency cases. The GAL program will accept dependency with cross-over delinquency cases to advocate for the best interests of the child when there are allegations of abuse, neglect or abandonment. The child must already be under court supervision.

Role in the Dependency/Delinquency System: Provides legal representation and advice to foster children, ages 13 to 19 years old, with a wide-range of civil matters, including: special education, medical/mental health/disability assistance, social security, landlord/tenant, contracts, and independent living services. Collaborates with community partners to facilitate optimum care of foster children.

When to Call: When legal advocacy is needed to address the areas delineated above.

Delinquency Proceedings:

<u>When to Call:</u> All youth charged with delinquent offenses are assigned a Intake Probation Officer. Call if any clarification is needed regarding a foster care youth charged with a delinquent offense.

Role in the Dependency/Delinquency System: Attorney ad Litem for children who have been charged with an act of delinquency or who have been charged with a crime (if State is prosecuting child as an adult). Act as defense attorney in defending child against prosecution and/or advocating alternatives to formal prosecution.

<u>When to Call:</u> When child is being sought for arrest or questioning by the police; when police are seeking to search child's person, property, vehicle or residence; or, immediately upon the arrest of child. Do not wait for a court date, if a child has been arrested.

Role in the Dependency/Delinquency System: Investigates and evaluates incoming juvenile complaints for delinquency prosecution.

When to Call: After an arrest, defendants, parents, victims, or case-related professionals may contact our office and they will be referred to the assigned attorney, if appropriate. Cases that have Public Defenders appointed are referred to their office and generally their attorneys contact our attorneys directly if needed.

<u>When to Call</u>: Please call when you have a high profile case or need to bring Executive-level personnel together to solve a complex or immediate issue.

In addition, call if the lead agency or contractors are unresponsive or have (in the view of the caller) made a decision that could negatively impact the safety or well-being of a child within the dependency system. Calls to me should take place once the proper chain of command within the system has been followed and presumably broken down.

Adverse consequences of a Juvenile Criminal History:

- Employment suspension or termination.
- Academic suspension or expulsion.
- Loss of scholarships.
- Denial of professional and/or occupational licenses.
- Loss of professional and/or occupational licenses.
- Loss of civil rights, including the right to vote.
- Loss of right to possess firearms.
- Administrative license suspension.
- Deportation or denial of citizenship for immigrants.
- Loss of reputation in your community.
- The time and cost to have record sealed or expunged
- Public humiliation.
